#### Overview

Assembly Bill No. 1204 requires the Department of Health Care Access and Information (HCAI) to develop and administer a Hospital Equity Measures Reporting Program to collect and post summaries of key hospital performance and patient outcome data regarding sociodemographic information, including but not limited to age, sex, race/ethnicity, payor type, language, disability status, and sexual orientation and gender identity.

Hospitals (general acute, children's, and acute psychiatric) and hospital systems are required to annually submit their reports to HCAI. These reports contain summaries of each measure, the top 10 disparities, and the equity plans to address the identified disparities. HCAI is required to maintain a link on the HCAI website that provides access to the content of hospital equity measures reports and equity plans to the public. All submitted hospitals are required to post their reports on their websites, as well.

General acute care hospitals are required to report several HCAI All-Cause Unplanned 30-Day Hospital Readmission Rates, which are broadly defined as the percentage of hospital-level, unplanned, all-cause readmissions after admission for eligible conditions within 30 days of hospital discharge for patients aged 18 years and older. These rates are first stratified based on any eligible condition, mental health disorders, substance use disorders, co-occurring disorders, and no behavioral health diagnosis. Then, each condition-stratified hospital readmission rate is further stratified by race and/or ethnicity, non-maternal age categories, sex, payer type, preferred language, disability status, sexual orientation, and gender identity. #### Plan to address disparities identified in the data

In response to the requirements of California Assembly Bill 1204 (AB 1204), this report presents our analysis of health status and access disparities within our service area. Utilizing the Hospital Quality Institute (HQI) Platform with SpeedTrack we were provided our top ten (10) disparities. Our plan for addressing these disparities is detailed herein.

All ten (10) of our top disparities are apparent across patients captured as an All-Cause Unplanned 30-Day Hospital Readmission. Below we outline a Readmission Reduction Plan to address contributing factors to unplanned readmissions, including health disparities in our patient population.

Disparity 1 & 2: Medicare & Medicaid patients relative to private payers.

Population impact: Patients with Medicare/Medicaid show higher readmission rates compared to privately insured patients.

Actions planned:

Care Coordination: support continuous improvement of multidisciplinary teams (nurses, social workers, pharmacists) for transitional care management

Data Integration: a readmission risk calculator is in place in the electronic health record to identify high-risk patients and automate alerts for the care team

Social Determinates of Health (SDOH) Screening of Medicare/Medicaid patients for needs before discharge

Continue support of and investment in community partners to prevent unplanned readmissions for Medicaid patients

Disparity 3, 6, 7, 9: Racial and/or ethnic disparities experienced by the following groups:

Native Hawaiian or Pacific Islander

Multiracial and/or Multiethnic (two or more races)

Black or African American

Hispanic or Latino

Population impact: The above patients experience higher readmission rates compared to Asian patients. Asian patients experience the lowest readmission rates at our hospital.

Actions planned:

Care Coordination: support continuous improvement of multidisciplinary teams (nurses, social workers, pharmacists) for transitional care management

Data Integration: a readmission risk calculator is in place in the electronic health record to identify high-risk patients and automate alerts for the care team

Continuous improvement of interpreter services

Ensure adequate linguistic & communication support during discharge

Community Partnerships: link patients to housing, food, and transportation resources

SDOH Screening of all patients 18 years and older for needs before discharge

Disparity 4 and 8: Patients age 35-49 & 50-64

Population impact: Adults 35–64 experience higher unplanned readmissions compared to younger patients.

Actions planned:

Develop age-specific care transition programs (e.g., medication reconciliation, caregiver engagement, follow-up calls)

Data Integration: a readmission risk calculator is in place in the electronic health record to identify high-risk patients and automate alerts for the care team

Community Partnerships: link patients to housing, food, and transportation resources SDOH Screening of all patients 18 years and older for needs before discharge

Disparity 5: Patients age 65 and older

Population impact: Adults 65+ experience higher unplanned readmissions compared to patients under age 35.

Actions planned:

Age-Friendly CMS structural requirement implementation (age-specific care transition program)

Data Integration: a readmission risk calculator is in place in the electronic health record to identify high-risk patients and automate alerts for the care team

Further develop ambulatory Senior Strategy to prevent unplanned readmissions SDOH Screening of all patients 65 years and older for needs before discharge

Disparity 10: White patients compared to Asian patients

The rate ratio for this group is 1.0 which does not indicate a significant disparity. We will continue to monitor this while prioritizing action plans for the groups with rate ratios >1.0.

For all disparities above, the Readmission Reduction Plan measurable objectives are: Reduce 30-Day All-Cause Readmission Rate by 10% in Native Hawaiian or Pacific Islander, Multiracial and/or Multiethnic (two or more races), Black or African American, Hispanic or Latino patients

Increase SDOH screening rates of patients admitted 18 years and older by 20% by year-end 2026

Timeframe for all of the above: All elements implemented by Q2 2026; evaluate biannually

## Performance in the priority area

General acute care hospitals are required to provide hospital equity plans that address the top 10

disparities by identifying population impact and providing measurable objectives and specific timeframes. For each disparity, hospital equity plans will address performance across priority areas: person-centered care, patient safety, addressing patient social drivers of health, effective treatment, care coordination, and access to care.

#### Person-centered care

Overview:

Person-Centered Care at Concord Medical Center focuses on ensuring that every patient receives care that respects their language, culture, identity, and individual needs.

**Equity Considerations:** 

We prioritize removing barriers for patients with limited English proficiency (LEP) and those from diverse backgrounds by tailoring communication and engagement strategies.

Programs & Practices:

Language Access: All patients are screened for language preference at registration. Qualified interpreters are provided for non-English encounters via phone, video and in-person interpreters. Patients speaking Spanish can access their health information through Spanish MyChart and all patients who select a non-English preferred language receive their After Visit Summary (AVS) in their preferred language.

Communication access: Our patients' profile in the electronic health record includes visuals to help staff identify a patient's communication's needs beyond language access including hard of hearing, visual impairment which allow staff to offer patients with additional accommodations.

Demographic Data Collection: Patient Access Services staff receive annual training to accurately collect self-identified demographic data, including race, ethnicity, preferred language, gender identity, and sexual orientation. Patients also have the option to self-identify using MyChart. Patient & Family Advisory Council (PFAC) members actively participate in Board meetings, performance improvement sessions, and Quality & Patient Safety committees, ensuring patient voices influence decision-making.

Performance Data:

Annual audits show consistent improvement in capturing race, ethnicity, language, sexual orientation and gender identity data.

Improvements & Plans:

Expand interpreter coverage to reach 100% compliance by Q3 2026.

Enhance culturally tailored materials and digital resources for top non-English languages by mid-2026.

Increase PFAC diversity representation to better reflect community demographics by end of 2026. Community Partnerships:

Our Community Health Improvement program provides funding to ensure interpreter service access to all patients that access our specialty oncology program which is a partnership between JMH oncology and La Clinica (a Federally Qualified Health Center).

#### Patient safety

Overview:

Patient Safety at Concord Medical Center centers on preventing harm events and ensuring accountability across all levels of care.

**Equity Considerations:** 

All harm event metrics are stratified by Race, Ethnicity, and Language (REAL) to identify disparities and guide interventions.

Programs & Practices:

Integrated Patient Safety Program with event reporting and risk mitigation

Board and leadership accountability for safety outcomes

PFAC representation on Quality & Patient Safety Committee

Performance Data:

True North Measure: Harm Events (composite measure of falls, pressure injuries, hospital-acquired conditions, and other harm events)

REAL-stratified safety metrics reviewed by committees

Improvements & Plans:

Reduce harm event rate by 10% by end of 2026.

Expand REAL-stratified dashboards for frontline teams by Q1 2026.

Addressing patient social drivers of health

Overview:

We aim to identify and address health-related social needs (HRSNs) impacting patient outcomes.

**Equity Considerations:** 

Screening protocols are being implemented to screen adult patients for social needs and those who screen "positive" for a HRSN are connected with community resources before discharge.

Programs & Practices:

SDOH screening for patients 18+

Care team provides list of resources to all patients who screens positive for any needs

Case Management team connects patients to internal and external resources for more complex needs such as housing insecurity or intimate partner

Performance Data:

Current SDOH screening completion through Q3 2025: 37%

Improvements & Plans:

Increase screening rate by 20% by end of 2026

Community Partnerships:

Community Health Improvement program provides multi-year funding to partners working to address SDOH including local food banks, non-for profits providing shelters, day programs, and short-term housing for unhoused individuals etc.

## Performance in the priority area continued

Performance across all of the following priority areas.

Effective treatment

Overview:

Providing evidence-based, timely, and appropriate clinical care for all patients.

**Equity Considerations:** 

Promote Clinical decision support tools and EBP pathways to reduce unconscious bias that could lead to disparities in treatment and outcomes.

Programs & Practices:

Continue to work to eliminate unnecessary clinical variation through utilization of existing evidencebased order sets to reduce unconscious bias

Further analyze disparity data by diagnoses to determine whether symptom or disease specific opportunities

Continue development of integrated ambulatory senior strategy

EHR alerts and provider education to close gaps in guideline-concordant care

Improvement and plans:

Monitor order set utilization

Leverage opportunities identified with stratification of readmission data by diagnosis

Community Partnerships:

Community Health Improvement program provides multi-year funding to partners working to address SDOH and supports collaboration on overall senior strategy. The John Muir Health Foundation sponsors the Walnut Creek Diabetic Center.

#### Care coordination

Overview:

Ensuring care is organized across providers, settings, and time for all populations.

**Equity Considerations:** 

Special focus on transitions for vulnerable groups, including unhoused and patient populations experiencing disparities.

Programs & Practices:

Homeless closets at both campuses ensure appropriate clothing is available for all unhoused and vulnerable patients upon discharge.

Social work consults are completed for all identified unhoused patients to ensure appropriate resources are provided, including but not limited to medical follow-up, clothing, transportation, mental health support, and a meal prior to discharge.

Inpatient CM/SW leaders meet weekly with Executive Leadership to discuss the most complex, vulnerable, and long–length-of-stay patients.

Charity Care funds are available for patients without financial means or insurance coverage to support needs such as medications, durable medical equipment, and transportation.

Performance Data:

As of 11/25/2025, 673 unique unhoused patients have been served in 2025.

Improvement Plan:

Re-education at the October Social Services staff meeting on flagging unhoused patients in Epic to ensure all receive adequate resources and support.

Additional inpatient case management and social work staffing on weekends to ensure vulnerable patients have timely access to discharge planning and support (effective Q4 2025).

Community Partners:

New collaboration with Hospice of the East Bay allows patients who do not meet insurance criteria and cannot afford private pay at Bruns House (hospice facility) to be discharged there for their final days of life.

Ongoing collaboration with Trinity Center, H3/CORE, and Respite Shelter to support unhoused patient care needs.

Partnership with County Homeless Services allows select JMH social workers access to the HMIS database, improving communication and care coordination across the various programs patients may be connected to.

#### Access to care

Overview:

Ensuring patients can obtain timely, culturally appropriate services without barriers.

**Equity Considerations:** 

Addressing insurance, income, and health literacy gaps to improve access for vulnerable populations.

Programs & Practices:

Mobile health clinic provides primary care to uninsured and underinsured patients in East and Central Contra County

Specialty care program: partnership with La Clinica and other community-based organizations to provide specialty care for Medi-Cal patients

Operation Access: funding to provide surgery for uninsured patients

Community nurse program: JMH places a school nurse in three elementary schools in Pittsburgh to support students and their family access primary care and other resources

Diabetic foot infection pathway, which is more common in patients who are limited in access to care Charity Care funds are available for patients with transportation needs.

Performance Data:

Mobile health clinic serves over 600 patients every year

Improvements & Plans:

Expand mobile health clinic by 2 clinic days per month by Q2 2026

Increase community nurse by .5 FTE by end of 2026

Community Partnerships:

Access to care is a priority health need identified in the 2025 community health needs assessment conducted by John Muir Health. We partner with 10 community-based organization that address access to medical and mental health care, including services to patients who do not speak English as their first language.
